Terms and Conditions of Participant Registration for the WOCSDICE- EXMATEC 2026 Conference

§ 1. General Provisions

1.1. These Terms and Conditions form the basis of the organisation of the **WOCSDICE-EXMATEC 2026 Conference**, organised by **JOYTRIP sp. z o. o.**, ul. Kisielewskiego 4D, 80-275 Gdańsk, Poland, NIP: 5832959276, REGON: 220319553, KRS: 0000507285 (hereinafter referred to as the “Organiser”).

1.2. The Conference will be held on **24–28 May 2026 in Gdańsk, Poland**.

1.3. These Terms and Conditions are published on the conference website: <https://www.wocsdice-exmatec-2026.eu/> (hereinafter referred to as the “Conference website”) and define the rights and obligations of its Participants.

1.4. The provisions of these Terms and Conditions constitute an integral part of the registration process and are binding upon all Participants.

1.5. Any changes to these Terms and Conditions will be made public by posting them on the Conference website.

§ 2. Participation in the Conference

2.1. The conditions for participation in the Conference are as follows:

2.1.1. Registration through the online registration form available on the Conference website.

2.1.2. Payment of the applicable Conference fee as specified by the Organiser on the Conference website.

2.1.3. The Participant shall cover all costs related to participation in the Conference.

2.1.4. The Organiser shall issue an invoice for the participation fee (invoice details must be provided in the registration form).

2.1.5. Registration closes when the maximum number of participants has been reached or as otherwise indicated on the Conference website.

2.1.6. Submission of the registration form constitutes acceptance of these Terms and Conditions.

§ 3. Fees and Payments

3.1. Conference fees are as follows:

3.2. The applicable registration period (early/late/on-site) is determined according to the dates specified on the Conference website.

3.3. The payer is the entity ordering the service of participation in the Conference.

3.4. Failure to pay the Conference fee within 14 days of completing the registration form entitles the Organiser to cancel the registration without incurring any liability.

3.5. The Conference fee shall be paid as indicated by the Organiser through the payment system linked to the registration form.

§ 4. Cancellation Policy and Refunds

4.1. A Participant who has concluded a distance contract may withdraw from it within 14 calendar days without giving any reason and without incurring costs, in accordance with Article 27 of the Act on Consumer Rights of 30 May 2014 (Journal of Laws 2014, item 827, as amended). The request for cancellation should be sent by e-mail.

4.2. If a Participant cancels their participation **no later than 7 days before the start of the Conference (by 17 May 2026)**, the Organiser will refund the full amount paid within 14 days from the date of receiving the written resignation notice.

4.3. No refunds will be issued for cancellations made after 17 May 2026 or for no-shows.

§ 5. Organiser's Responsibilities

5.1. The Organiser shall make every effort to ensure the proper organisation of the Conference as described on the Conference website.

5.2. The Organiser reserves the right to make changes to the Conference programme, including changes to the schedule, order of sessions, and speakers, even on the day of the event.

5.3. Such changes do not constitute grounds for financial claims against the Organiser.

§ 6. Participant's Responsibilities

6.1. Participants are required to comply with these Terms and Conditions and to follow all organisational and technical instructions issued by the Organiser or its authorised representatives.

6.2. Participants are expected to conduct themselves in a professional and respectful manner during all Conference activities.

§ 7. Personal Data Protection

7.1. The Controller of personal data for the purpose of organising the Conference is **JOYTRIP sp. z o. o.**, ul. Kisielewskiego 4D, 80-275 Gdańsk, Poland.

7.2. Personal data will be processed for the purpose of participant registration, communication, invoicing, and organisational arrangements related to the Conference.

7.3. Participants have the right to access, correct, and request the deletion of their personal data at any time. Providing personal data is voluntary but necessary to participate in the Conference.

7.4. The Organiser reserves the right to use external services to process registrations and payments.

§ 8. Complaints

8.1. Complaints regarding participation in the Conference should be submitted by e-mail to: **we2026@joyevent.pl**

8.2. A properly submitted complaint must include:

- Participant's full name, address, and e-mail address,
- Date of registration,
- Subject and justification of the complaint,
- Specific request of the Participant.

8.3. If additional information is required, the Organiser may request that the complainant provide supplementary details before the complaint is processed.

8.4. The Organiser shall respond to the complaint within 14 days of receiving it in its complete form. The reply will be sent to the e-mail address provided by the Participant.

§ 9. Final Provisions

9.1. The Organiser reserves the right to amend these Terms and Conditions.

9.2. In matters not regulated herein, the provisions of the Polish Civil Code shall apply.

9.3. These Terms and Conditions enter into force on **1 November 2025**.
